

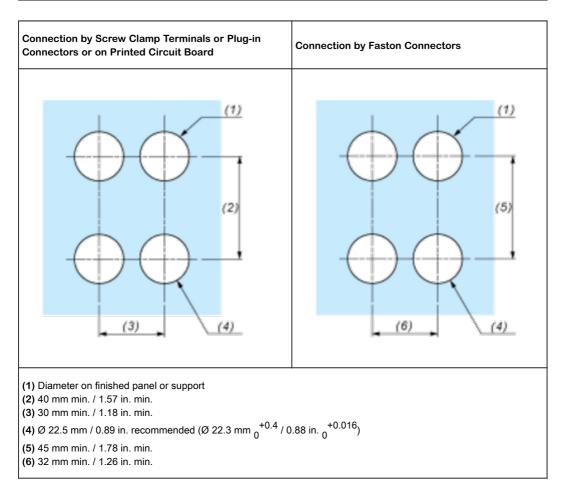



Pushbuttons, Switches and Pilot Lights for Printed Circuit Board Connection

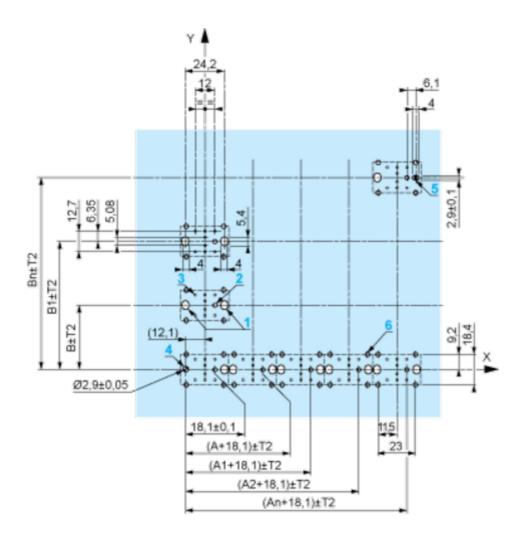
Panel Cut-outs (Viewed from Installer's Side)





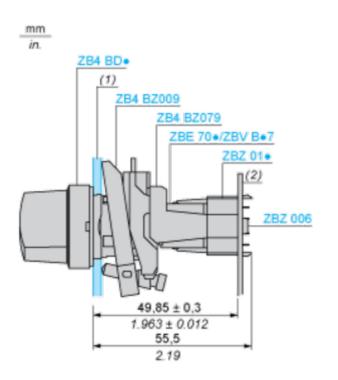


