This prospectus supplement (the "**Fifth Prospectus Supplement**") is supplemental to, and should be read in conjunction with, the Base Prospectus dated 25 April 2019 which received visa no. 19-176 on 25 April 2019 from the *Autorité des marchés financiers* (the "**AMF**") as supplemented by the first prospectus supplement dated 6 September 2019 which received visa no. 19-428 on 6 September 2019 from the AMF, the second prospectus supplement dated 25 October 2019 which received visa no. 19-502 on 25 October 2019 from the AMF, the third prospectus supplement dated 24 February 2020 which received visa no. 20-053 on 24 February 2020 from the AMF and the fourth prospectus supplement dated 31 March 2020 which received visa no. 20-102 on 31 March 2020 from the AMF (together, the "**Base Prospectus**") of Schneider Electric SE (the "**Issuer**"). The Base Prospectus constitutes a base prospectus for the purpose of the Directive 2003/71/EC on the prospectus to be published when securities are admitted to trading, as amended or superseded (the "**Prospectus Directive**").

Application has been made for approval of the Fifth Prospectus Supplement to the AMF in its capacity as competent authority pursuant to Article 212-2 of its *Règlement Général* which implements the Prospectus Directive.

This Fifth Prospectus Supplement has been prepared pursuant to Article 16.1 of the Prospectus Directive and former Article 212-25 of the AMF's *Règlement Général* for the purpose of increasing the aggregate nominal amount of the Programme:

Save as disclosed in this Fifth Prospectus Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus which is material in the context of the Programme since the publication of the Base Prospectus.

Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Fifth Prospectus Supplement.

To the extent that there is any inconsistency between (a) any statement in this Fifth Prospectus Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus or in the first prospectus supplement, in the second prospectus supplement, in the third prospectus supplement or in the fourth prospectus supplement, the statements in (a) above will prevail.
