



Right View, Front View and Front View with EMC Plate







Mounting Type A: Individual with Ventilation Cover









Control Connection Diagram in Source Mode







Switch SW1 set to "Source" position and use of an external power supply for the DIs.




Switch SW1 set to "Sink Int" position and use of the output power supply for the DIs.


