

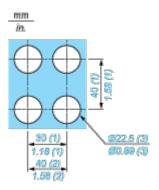



Faston Clip Connection




