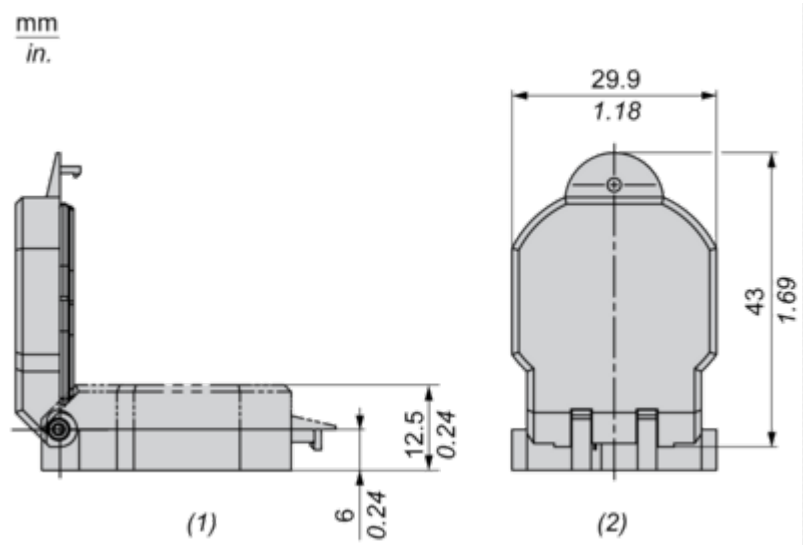

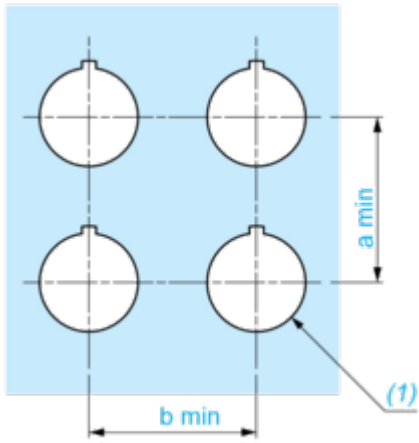


(1) Side View - Open
